



Radiology Services in Scotland – Patient and Carer Survey

They would appreciate your support to raise awareness with your networks and groups of a survey to gather patient and carer views about radiology services in Scotland. Radiology uses medical imaging (for example, X-ray, MRI, CT, ultrasound) to look inside the

body to diagnose, treat and monitor injuries and diseases. The survey is part of a national project looking at the future of radiology services and responses will help find out what is working well and where they can make improvements. The survey will be live from 9 December 2020 until 5 January 2021. The survey should take no longer than 10 minutes to complete. Scottish Government Research Survey to understand practical and emotional barriers to adherence with coronavirus restrictions

During the coronavirus pandemic, restrictions and guidance has been introduced to limit the spread of the virus. These important restrictions have changed the way we shop, travel, work and socialise. Evidence shows that some people are finding it difficult to follow the restrictions completely for a range of reasons. This short anonymous survey asks a few questions about experiences of coronavirus restrictions, to help understand barriers in more detail. It asks what people have found easy and difficult. Responses will help the Scottish Government continue to support people across Scotland to stay safe and keep their families and communities safe too. Disabled People's Views of the Fairer Scotland for Disabled People Delivery Plan

What do you think has changed? In 2016, the Scottish Government published its delivery plan for the United Nations Convention on the Rights of Disabled People called A Fairer Scotland for Disabled People. The Plan set out the things the Scottish Government was going to do over 5 years to 2021 to remove barriers faced by disabled people across all areas of life. The plan is due to finish at the end of 2021. But has anything

changed for disabled people in the four years of the plan? To find out Inclusion Scotland ran a short survey from Tuesday 10 November 2020 until Tuesday 17 November 2020 to ask disabled people their views. Funding

Food for Thought The Scottish Wholesale Food and Drink Resilience Fund provides grants to wholesalers suffering hardship as a result of the Covid-19 pandemic. Your business is eligible to apply if it is based in Scotland and:

- food and drink wholesale is the main or only part of the business (wholesale must equate to 80% or more of business turnover)
- it has seen a fall in sales by 20% or more since March 2020
- it is classed as a small and medium-sized enterprise (SME) as defined in the EU recommendation 2003/361 - that is, it employs fewer than 250 people and has an annual turnover of no more than €50m and/or an annual balance sheet total of no more than €43m.

New National Lottery project funding and loans to support resilience is once again accepting project funding applications up to £100,000. This National Lottery funding is there to help the heritage community recover from the effects of the pandemic, and re-engage with the communities hardest hit over the last year.

YouthLink Scotland: CashBack for Communities Youth Work Fund

Funded projects must be delivered between 1st April 2021 and 31st March 2022. They welcome proposals for the delivery of targeted youth work activity programmes for young people aged between 10 and 24 that:

- Support young people most at risk of being involved in antisocial behaviour, offending or re-offending into positive destinations.
- Support young people most at risk of entering the justice system.

A total of £700,000 is available. The closing date for applications is 1.00pm on Friday 18th December 2020. For more information go to
